For anything larger than 1" the City will charge the connection fee plus the actual cost of the connection on a time and materials bases.

TESTING WATER METERS (Section 2.28)

For any resident or business who wants their meter tested for accuracy:

1. The complainant must be present during the entire procedure, including removing the meter, and reinstallation.
- 2. The fee is \$100.00 for a 5/8", 3/4 " or 1" meter, plus work order fee (\$20)**
3. If the meter is defective, the fee will be reimbursed.

EFFECTIVE 8/1/17 BILLING

Water Rates/Fees

A quarterly base fee shall be paid depending upon the size of the meter used as follows: **\$5.25 per 1,000 gallons**

Buildings in all zoning districts other than the R1 residential or R2 residential districts, having more than one tenant and/or user supplied through one water service, shall be charged a quarterly service charge of \$20.00 per each additional apartment, office or other tenant.

Sewer Rates/Fees

\$60.20 per quarter

\$7.50 per 1,000 gallons

Single family residences not connect to City water shall pay a flat sewer rate of \$292.00 per quarter.

Building having more than one tenant and/or user supplied through one sewer service shall pay a rate of \$28.00 per quarter per each additional apartment, office or other tenant in excess of one.
